## 2. Committee Feedback

- **2.1 Introduction to Process:** Trish shared the feedback process with the group, outlining that each committee representative would have 10 minutes to share their feedback. At the end of all the feedback, there would be an additional 10 minutes for Admin Committee members to ask questions.
- 2.2 Feedback Exercise: We invited a member from each of the other "City Committees" to give us feedback on the proposed changes to their resolutions. Admin has already updated their resolution, the Audit and RTMP committees had no representative. Public Safety was unable to meet officially to discuss. One Admin Committee member felt these committees are to provide recommendations to city council and is opposed to staff voting on committees, as they should be there to provide feedback only to stay above reproach. A city employee stated that on behalf of the rest of the city employees, he feels as citizens of the United States they have the 14th amendment which gives the right to life, liberty and the pursuit of happiness. The pursuit of liberty is to pursue being on committees. He feels staff have the right to be on committees, unless due process removes it and does not believe a hypothetical rises to the occasion of due process
