How the Exemption application process works:

Once reviewed by the City of Oakridge, the City will process your application and send you a letter approving or denying your exemption eligibility.

If approved, *your exemption will only remain valid through the end of June*. You must *re-apply annually (by July 1st)* to continue to receive an Exemption for the *next* fiscal year.

Applications received *after* the 15th of the month will be applied to the *following* month. You are still responsible for any unpaid fees *prior* to submitting your annual exemption application.
