Rustie Ackland 47615 Commercial St- Our ambulance is important, we all know that. Fire, Police and Ambulance are the most important services we have. We are too far from Eugene and Springfield to be without it, she is in favor of us doing what we need to do to keep this service.

Linda McMahon 48429 Roberts Ranch Drive- She asked if we need \$60,000 to continue ambulance service that we have?

Susan said what we are doing is allowing the Fire Department to borrow \$60,000 from the OIP, it's a loan and will be paid back in three years. This helps cover the overages they had this year. In a nutshell, the revenues went down and the over time went up.

- g) Council Discussion

Councilor Holston thanked the staff in advance, they have done a great job managing finances over the last few years. She wants to encourage us all to believe that the measures they are going to be taking tonight are going to assist us in becoming financially stable for EMS and she thinks that they will. She does think it's prudent that we don't become passive about this, she would like the council to consider what it would look like if we privatize EMS. She wants to go about the business of finding out what that would look like so we are prepared. She asked Louis if he would make sure they get a report back every three months on the financial outlook on EMS, how is it looking? How are the runs doing? Are they improving?

Councilor Carl asked Chief Hansen if Councilor Holston's requests are within the parameters of what he feels is reasonable. He would also like to know from the City Administrator if he thinks reporting back the progress is reasonable or is it somehow in conflict with union negotiations.

Chief Hansen said it is reasonable to track progress. When they asked for the loan they needed to be sure they could show the council and the community that they are going to right this ship and they should be able to show that within six months. By the end of this year if they can't show that things are going in the right direction then that gives them the last six months of that fiscal year to then go forth with the private adventure. He would encourage them not to look into it too soon. They just need to focus on doing a great job and changing the way we operate, and they are.

Councilor Carl said he would hate to see us go to a private ambulance company, he truly regrets that we ever gave up our local dispatch, we can never go back and he is afraid the same thing would be true with ambulance services. He applauds their efforts to do what he is working on doing and he supports that.

Susan said one thing that the employees have put on the table to show that they are dedicated, is that they are forgoed their cost of living raises this year. They realize there is a problem.

Louis said the quarterly piece is good, in between the quarters your get your monthly revenue and expenditure report.

h) Council Decision

Motion: Councilor Holston move that we approve Resolution 4-2017 Supplemental Budget for a loan of \$60,000 from the OIP Fund to the Emergency Services Fund to be paid back with interest at 1% over the next three years, first payment due in fiscal year 2018, \$55,000 transfer from General Fund and adjustments to the Wood Stove Fund, Community Center Grant line and correction of scriveners errors in the EMS Fund and the Water Reserve Fund. Councilor McMillin seconded the motion.

9.1 IGA with City of Westfir for Fire Protection Services

Louis said our Fire and EMS collaborates with Hazeldell Fire District and the City of Westfir combined as basically one department. The City of Westfir supplies a first out engine for us and we sue fire tenders from Hazeldell.

Chief Hansen said this is an increase of 3% from last year.

Motion: Councilor Holston moved that the Mayor sign the IGA with the City of Westfir to provide Fire Protection Services. Councilor McMillin seconded the motion.
