Ethics Question

Chrissy -

As we discussed, the key to our analysis is to look at whether you are taking any action, or making a decision or recommendation, in your role as a public official that is to your private financial benefit, or that of a relative or a business with which you are associated. You have indicated that in addition to being a City Councilor, you serve as a volunteer firefighter/EMT for the Oakridge Fire Department, and that your husband is a Fire Department employee. You have also indicated that you do not vote on the City's budget because of the conflict of interest that would arise. Your question is whether you can accept a stipend that is paid by the City's Fire Department to all volunteer firefighters.

You are correct that because of your position as a Fire Department volunteer and your husband's position as a paid Fire Department employee, you would, as a City Councilor, have an actual conflict of interest in any discussion or vote on the City budget that includes the budget for the Fire Department. (See ORS 244.020(1) and (13)). You would also have a conflict of interest in any City Council discussion or deliberation related to appointment of or stipends for Fire Department volunteers.

ORS 244.040(1) prohibits a public official from using or attempting to use an official position to obtain a personal financial benefit or avoid a financial detriment for the official, a relative or household member, or any business with which the official, relative or household member is associated, if that benefit would not otherwise be available "but for" holding their official position. This means that in general, as a City Councilor, you are prohibited from attempting to obtain any form of financial benefit from the City (i.e., a stipend) that a similarly situated member of the public does not have the same opportunity to access or obtain.

A public official is allowed to accept any part of an official compensation package. [ORS 244.040(2)]. An official compensation package is defined as the wages and other benefits provided to the public official. To be part of the public official's "official compensation package," the wages and benefits must have been specifically approved by the public body in a formal manner, such as through a union contract, an employment contract, or other adopted personnel policies that apply general to employees or other public officials. [OAR 199-005-0035(3)]. A stipend, if formally adopted by the public body, would be part of an official compensation package.

In this case, the stipend you reference appears to be part of the official compensation package offered to Fire Department volunteers. From the information provided, it does not appear that you would be using or attempting to use your position as a City Councilor to approve the stipend or even the budget for the Fire Department. Thus, it does not appear that you would be using your official position to obtain a personal financial gain that would not otherwise be available but for your position. As one of the Fire Department volunteers, you would be permitted to accept the stipend so long as you have not used your position as a City Councilor to increase the stipend or increase the number of days you get called out (thus, increasing the stipend days which you would be entitled to claim).

Although ORS 244.010(4) recognizes that public officials may hold more than one position in a public capacity, you must also be twice as diligent to ensure compliance with Oregon Government Ethics laws while serving in both positions, as a Fire Department volunteer and as a City Councilor. Issues concerning ORS 244.040 and conflicts of interest are probably most likely to arise in relation to personnel matters, such as compensation or benefits. For example, as a City Councilor, you cannot act to recommend or approve the stipends paid to Fire Department volunteers or deliberate on your continued appointment as a Fire Department volunteer. So you must remain vigilent and avoid any participation in City Council actions, decisions or recommendations that might have a financial impact on the Fire Department and its employees and volunteers.

I have no positions of authority that recommends or decides how much stipend is budgeted for volunteers.

I do realize that both being a city Councilor and ALSO being a volunteer firefighter/EMT are considered public officials and if the topic should arise in a council meeting to discuss volunteer Stipend, I should recuse myself from that subject matter and/or vote.

Councilor Kinyon 9/19/19

During the budget committee session earlier this year, it was discussed and agreed that the budget committee needed to meet to discuss a supplemental budget for 19-20 asap into the new fiscal year for a variety of reasons but mainly that the FD budget was not going to work. Then on July 25th the council made a motion that passed unanimously scheduling a budget committee meeting for Sept 12 and another on Oct 10th.

On the night before the Sept 12th meeting, I asked where we were meeting and had the budget committee been notified. Over the course of the next several hours I learned that Mayor Holston had previously discussed the matter with our CA. They must have decided not to have the meeting, and forgot to discuss or basically "inform" the council of their decision. Then she asks Bryan and Rick not to post the meeting, as it is canceled. Again making a decision for the council instead of with the council. This meeting was scheduled by motion and a vote of the council. (attachment: Pre Meeting Topics for Budget meeting Discussions) (attachment: email thread between Bryan, Kathy, Rick Z and myself)

My concern here is less about the reason the meeting was canceled - and more about the issue of the mayor, who is only one member of the council, meeting with the CA and directing him or making a decision together. You will see what I mean by reading through this email thread in order. That is not how it's supposed to work. Our charter outlines that all seven of us make up the council.

Now I have realized that on June 5th this year the mayor and our former Interim CA entered into an engagement contract with our CPA - without a discussion at council or council approval. Again undermining the value of the government as directed by the people of Oakridge through our Charter.

On a few occasions this year I have suspected the Mayor was directing our previous interim CA's but I was not a part of council then. I cannot prove it, but I have a strong suspicion based on the state of our Fire department, she has been influencing our CA's of her own will and not allowing the will of council.

For these reasons, I move to censure Mayor Holston.

From the Charter:

Section 6. Where Powers Vested. Except as this charter provides otherwise, all powers of the city shall be vested in the council.

Section 7. The council shall be composed of a mayor and six councilors, elected from the city at large.

POWERS AND DUTIES OF OFFICERS

Section 19. Mayor. The mayor shall appoint the committees provided by rules of the council. The mayor shall sign all approved records of proceedings of the council. The mayor shall have no veto power and shall sign all ordinances passed by the council within three days after its passing. Upon the approval of the council, the mayor shall endorse all bonds of city officers and all bonds for licenses, contracts, and proposals, and countersign all orders of the treasury.

(6) The administrator shall:

- (a) Attend all council meetings unless excused by the council or mayor.
- (b) Keep the council advised of the affairs and needs of the affairs and needs of the city.
- (c) See that the provisions of all ordinances are administered to the satisfaction of the council.
- (d) See that all terms of franchises, leases, contracts, permits, and privileges

granted by the city are fulfilled;

- (e) Appoint, discipline and remove appointive personnel, except appointees of the mayor or council.
- (f) Supervise and control the administrators' appointees in their service to the city.
- (g) Organize and reorganize the departmental structure of city government.
- (h) Prepare and transmit to the council an annual city budget.
- (i) Supervise city contracts
- (j) Supervise operation of all city-owned public utilities and property; and
- (k) Perform other duties as the council prescribes consistently with this charter.


The budget meeting was tentative on my calendar and at this point too early. The first meeting must appoint the budget office and publish the budget message.
