CALL MEETING TO ORDER - 6 pm

- 1. The City Administrator made some opening remarks about the reasoning behind rescinding the Revenue Sharing and FY 20-21 Budget due to improper scheduling of the first public hearing and lack of a quorum at the hearing. Mayor Holston mentioned attorneys had been consulted to determine the proper action.
- 2. Individual motions were made and seconded to rescind the budget and ad valorem taxes approval. The vote passed and a summary is presented at the end of this document. Councilor Kinyon asked if the public hearing was to consider the FY 20-21 budget. Mr. Jones responded that the public hearing at the budget committee level was only to consider the city's election to receive state revenues.

 - -The CA responded LCOG and the LOC counsel were contacted.
 - 4.2 Approval: A motion was made and seconded to approve the FY 20-21 Property Tax Levy and FY 20-21 Budget. Both motions passed and the vote summary is presented at the end of this document. Ms. Bjarnson asked to clarify the vote on the budget and the CA confirmed the attendance and vote.
- 5. Chairman Gobelman received consensus on the committee meeting in January to conduct training.
- 6. Meeting adjourned.
