SUBJECT: Review proposed scope of work and budget for Willamette Activity Center (WAC) cost estimate.

BACKGROUND: The City Engineer issued a report for the renovation of the WAC in 2010, which cost \$10,000. The Council requested an update to the original cost estimate to understand the ramifications of a renovation or redevelopment of the site. Staff requested a scope of work and budget (enclosed) from the City Engineer. The information gathered will also help the City Council make an informed decision about the future use of the building and site. The update will cost the following:

\$4,500 - Report
\$1,500 - Structural Analysis
\$6,000 - TOTAL

Staff is requesting City Council review and approval to authorize the work, which is expected to take about four months to complete. The final report will be presented to the City Council at this time.

RECOMMENDATION: Staff recommends approval subject to any specific conditions authorized by the City Council.

RECOMMENDED MOTION:

FINANCIAL IMPACT:

SCOPE OF SERVICES AND FEE ESTIMATE**

Dear Kevin:

Pursuant to our conversation about this matter here is an estimate to update the renovation construction cost estimate for the City's existing WAC facility, originally prepared by CURRAN-McLEOD, INC. in 2010.

It is anticipated that the project will include a site visit, update of all cost estimates, a comparison of demolition and new construction versus refurbishment of existing facility, and a summary letter report. The total cost of CURRAN-McLEOD INC.'s services will be \$4,500.

In light of the time passed since the original report was completed and our understanding that significant deterioration of the facility structure has occurred, we would also request that our structural engineer, Hayden Engineers, review the facility with us. The scope of their services would be inspection of the building shear walls, roof connections, and beam systems to assess their structural integrity. The review would also focus on seismic upgrades required by changes in the Oregon Structural Specialty Code, occurring since 2010. The additional cost of this review would be \$1,500.

The total amount requested is \$6,000. A cost break out of the services required for the update is summarized in Table 1, attached with this letter. Once notice to proceed is given for this work, we anticipate that the revised report will take three months or less to complete.

SUBJECT: Review bids for new excavator and authorize purchase.

BACKGROUND: The Public Works Department would like to purchase a new excavator to replace an existing one that is in very poor condition. The excavator can be used for various city projects including installation of utilities at the Oakridge Industrial Park and emergency response. The machinery is vital to PW operations as well as to make repairs after natural disasters. The new machinery also has multiple capabilities for attaching other equipment.

The purchase was budgeted for FY 2021-22. Enclosed are three bids from vendors with varying costs. The preferred bid is with Sonsary Machinery CASE CX16D for \$208,299. This exceeds the \$200,000 that was budgeted but can be absorbed with other budgeted funds.

Staff is requesting City Council review and approval to authorize the purchase. Delivery cost is included in the bid and the excavator is already ready for delivery.

RECOMMENDATION: Staff recommends approval subject to any specific conditions authorized by the City Council.

RECOMMENDED MOTION:

"I move to approve the purchase and authorize the City Administrator Pro Tem to execute a contract."
