Preference Points for Veterans

Per ORS, a person seeking to fill a vacant position may be eligible for Veteran preference points. To receive Veteran preference points, you must submit a copy of DD 214 in your application packet. Veteran preference points will be applied to the final score of candidates that meet the minimum qualifications and achieve a minimum passing score of 75% in the testing process.
