# 6.1 City Administrators Report

Louis, Councilor Buchmeier and George Custer had a meeting with LTD in regards to a grant they put in earlier in the year for \$632,000 and they did not receive it. The goal was to add additional trips into the city on the weekends and to increase trips during the week. They are regrouping and looking at the grant again.

Pedestrian Study - We had a kick off meeting on the Pedestrian Study with the engineers and consultants that are doing the study for us. Louis gave them a copy of the Highway 58 Refinement Plan since there is a lot of material in there that they can utilize.

Empty Lot on Hwy 58 - Louis sent some correspondence to Tyco, LLC to see if we can get some movement on that lot.

Million Gallon Tank and Well – This comes back to the motion for the Mayor to sign the letter in 6.6.

Teller Road Construction Project – They want to start that project the first or second week of October.

The Sale of the Building at the OIP – Will talk about this in executive session.

Enterprise Zone – We are starting the first step of the enterprise zone again, it will start with us and Westfir and The Board of County Commissioners has to pass a resolution and it will be forwarded back to business Oregon and shortly after we will have our enterprise zone back.

ODOT Grant – We spoke with Frannie Brindle in regards to getting some non-road money. We are talking four years out, but the dollars would be secure and they could be used to finish the IMBA Ride Center projects.

# 6.2 City Recorders Financial Report

Susan presented the financial report to the council.

**Motion:** Councilor Rowland moved to approve the Financial Report as presented. Councilor Chitwood seconded the motion.

Councilor Kinyon asked Susan if she could explain what the ambulance account is.

Susan said it is a tracking account, the Springfield Fire and Life Safety does our billing for the ambulance accounts.

## 6.3 Resolution 17-2015 Designation of the Oakridge Westfir Enterprise Zone

The Oakridge Westfir Enterprise Zone expired December 31, 2014, Enterprise Zones are redesignated for ten year project periods, if there is no activity in the zone within a six year period then the enterprise zone expires, which is the case with ours. Business Oregon is working closely with the city, without the enterprise zone it is difficult for the city to offer tax incentives to businesses that may want to locate to the Oakridge Westfir Enterprise Zone, it is imperative that we get our enterprise zone designated so we can be more competitive to attracting new businesses.

On our original enterprise zone we did not include new hotels or resorts, so if a new hotel or resort came into the area they would be eligible for the tax exemptions.

**Motion:** Councilor Carl moved that we adopt Resolution 17-2015 designation of the Oakridge Westfir Enterprise Zone. Councilor Rowland seconded the motion.

#### 6.4 Water Curtailment Discussion and Down grade to Normal Use

Back on July 27, 2015 the council established an ordinance for water curtailment, since that time the community has been curtailing anywhere from 190,000 - 220,000 gallons a day. Which showed the community at large took the curtailment seriously. Louis is recommending that the city council lift the water curtailment. We are asking that the community to please work towards conserving water as a normal practice.

**Motion:** Councilor Zylstra moved that we lift the water curtailment level from moderate mandatory and return to no restrictions. Councilor Carl seconded the motion.

Councilor Carl asked Chuck Kurnick about the rock quarry that will possibly go in, will that inevitably affect our water supply?

Chuck said no he does not think it will affect it at all. The rock quarry will help us in one respect by letting us put our tank in another better location.

# 6.5 Facilities Use Permit Administrative Update

We talked about this at the community services meeting, the initial thought was that this was very narrow and it didn't have anything spelled out such as what kind of sanctions or examples.

Susan said there were people that were concerned that they didn't give examples on what they were looking at. The way the parks are ran is not changing, this is just if problems arise. This is just giving us the tools that we will need when problems occur at the park

**Motion:** Councilor Rowland moved that we approve the additional language as presented on the facility use permit. Councilor Zylstra seconded the motion.

Susan said the fines would be different for each person or occurrence.

Councilor Carl asked who decides what good order is or not?

Louis said if this council gives a directive to a certain event and they don't follow it, then they are in violation of good order. It will be up to the discretion of the police department to see if the evidence is there, at least 51% to see if there was a violation of good order.

Councilor Kinyon wanted to know who was going to decide whether or not rules are followed.

Mayor Coey said it will be city staff or Louis, it will probably come from Chief Martin first to Louis.

They sent two officers to Smoke School and they will come back and train more employees.

The Volunteers are working hard upstairs to make them a work out room.

Today is the last day for one of their fire fighters, we will be going through the hiring process to replace him.

Banner Bank donated the corner lot on E 1<sup>st</sup> Street and Cedar, the location of the old bank that burned down, to the City of Oakridge.
