 - d) Statements in Favor –

Commissioner Brown asked how big the billboard going to be.

Commissioner Custer said it is 8 ½ 'tall by 20' long.

Commissioner Carl said the sign has been designed by a professional Engineer, they have the necessary permits and the City Council has approved their request. Now they are asking for the variance because this exceeds the size limits.

Louis said the issue is not the size of the sign; the issue is because it is considered off premise type advertising.

e) Statements in Favor - Mr. Patel owner of the Best Western Hotel; 90% Of his guests don't even know we have an uptown. He feels we do need to have a sign somewhere letting people know about Uptown.

Denise Cater; owner of the 72 Oaks Bed & Breakfast and the Hitching Post. She thinks this is a great idea; anything that promotes the City is a good idea.

Steve Saxon is in favor of the sign, in doing this we might get the rest of the City to get on board and promoting our town as a whole. We are showing pride in our businesses.

Sandy Price; she is in favor because she is the one who answers the Chambers phone, people do not know about the uptown, that we have a post office and banks.

g) Statements in General - Pastor Fred Ulrich asked if we are going to cut any of the trees down for this sign. He is a little concerned that we do have a lot of signs in that area.

Commissioner Custer said no we are not. The sign will be right in front of the trees.

Nancy Kelly said we have a lot of traffic uptown and people have trouble finding their way back to the Highway.

Commissioner Custer said that is a concern and we have other committees working on this very issue. That is a concern.

- i) Commission Discussion Commissioner Altemus asked what the Billboard is going to be made of.

Commissioner Custer said it will have a vinyl wrap, most billboards are made of this now.

Commissioner Brown asked about the lifespan of the billboard. He is concerned about the upkeep of it later on down the road.

Commissioner Carl said the life expectancy is 3-4 years; UBRA has already discussed not only maintenance but replacement of the sign. It's not that expensive so when it starts looking deteriorated they will replace it.

Louis gave an update on the visitor center; we are trying to get a crosswalk in, the city has been in discussions with the property owner of the property on Rock Road and Highway 58 for a visitor's center.

There is a good probability through swap or purchase the City will be able to put our visitor's center at that location. He is hoping to have something to take to City Council within the next 3-4 weeks.

Commissioner Affa asked at what point does different colors on a building become a pattern.

Louis said that would be a judgment call on his part, that is some of the latitude that he has.

15.02 Mobile Home Park Sub district (/MHP)

(3) Uses and Structures Permitted conditionally in Residential Districts

There was discussion on green roofs; it wouldn't hurt to leave it. Some of the newer mobile homes might be sturdy enough to hold them, and there is the club house and restrooms.

Louis said we can let it be their call.

Commissioner Kordosky said so this will open it up to anyone to just put some dirt on their roof and decide to plant their crop. It won't be structurally sound.

Louis said this is only in the mobile home park and it is their call. They will have to request a permit.

Motion: Commissioner Carl moved that we add the suggested language in paragraph (g) in its entirety beginning with Stormwater mitigation measures and ending in the words rain barrels, green roofs. Commissioner Affa seconded the motion.

Commissioner Custer said you will still have to submit your landscaping plans with lot coverage to the engineer.

Louis said in this case when the plans come in that is something they are looking for. Our review is primarily zoning. Most of this would be up to Jackie and The Building Department.

Motion: Commissioner Affa moved to accept 15.02 (9) sub section (d) Space Coverage and Density as presented. Commissioner Kordosky seconded the motion.

(2) Installation and Construction

Commissioner Carl said we are setting up areas where crime can be committed, where drug trafficking can take place; we are having site obscuring fences or hedges. He realizes it is to hide storage areas but, we also need to realize when we create these site obscuring nooks and crannies in the MHP's we might be contributing to problems that we already have.

Louis said he looks at it like these are already allowable things in our code. If St. Vincent DePaul doesn't want to have fences or anything like that they don't have to.

Commissioner Custer said common storage areas "shall" be surrounded except at entry and exit places.

Louis said they have their variance already and he doesn't know that they are putting in any new Mobile Home Parks. This is for new development.

Commissioner Altemus said shall is a strong word; he is all for using the word may instead.

Motion: Commissioner Carl moved that paragraph (h) be amended and adopted as written with the change of the word shall to may and everything else to remain the same. Commissioner Affa seconded the motion.
