# PUBLIC HEARING CONCERNING 2006 COMMUNITY DEVELOPMENT BLOCK GRANT

Mayor Bond opened the public hearing for discussion.

1.1 Staff Report

Gordon Zimmerman said there are two reasons for this Public Hearing. The first reason is to discuss the community housing needs. The Oakridge Warm Homes Project has identified 160 homes that need assistance in rehabilitation, weatherization, and energy efficient remodels. The question now facing Oakridge and the other community partners in the Warm Home Project is the amount of money available. A CDBG grant could help with those homes identified within the City limits.

The other project is a new library. The Council goals last year and this year both identify the need for a new library as crucial for the city. The Council has previously seen the plans for the library.

Councilor Fortune asked about the size of the grant for housing rehabilitation.

Councilor Schorer stated that she wished that the library could have been built more towards Highway 58. However, she thinks the current plan is great and that the Council should go for it. Councilors' Fortune, Clark, and Hampton agree that the staff needs to proceed with the request.
