**Regional Fiber**: The people working for them failed to produce and were relieved of the contract. A new company has taken over the contract. A meeting will be held shortly.

Councilor Clark: We learned at the Telecommunication meeting. The league of Oregon cities has set up a task force. There are only 4 who have telecommunication fees in addition to Franchise fees. Many communities are losing the funds due to the use of Cell phones. The loss of funds is due to the decline in home land line phones.

Mayor Hampton explained due to the loss the League wants to tax users.

#### 10.0 MAYOR AND COUNCIL COMMENTS

10.1 Council Starts at 6:00 p.m. August 21, 2008

Let's keep the start time and have a town council meeting before the meeting. In addition we will move the Mayor and Council comments to behind the Public Comment.

Mayor Hampton stated that the current Speaker of the House, Jeff Merkley will be in the City next Tuesday at the Trail Head café.

Regarding the public comments, the press has a right to be here. They also have a responsibility to not report when told. Labor negotiations are the only executive session where they are prohibited. There is no law requiring us to have public comments. I am required under the Charter to maintain order and conduct business. It is more useful of resources to contact Councilors by phone. This will give staff time to research and give comments. There is a difference in listening and agreeing to your points of view. If you are not satisfied with the people who listen you can vote to elect someone who will listen to your point of view.

I went to the Oregon Mayor's Association; it was mostly tours, not a valuable learning session. The Oregon Mayors Association recommended repealing or modifying the double majority rule. The second motion passed was a motion to exempt construction Ballot Measure 21. The measure asks to support public drinking water and for public entities to stop buying bottled water. Over 200 officials have resigned due to the Ethics Laws. Reform from the League of Oregon Cities is recommending changes to this measure.

There is one correction to the League of Oregon Cities events, the dinner is not \$40 it is \$70. The City should pay for the Mayor and Councilors workshop meals and registrations. The City should not pay for Spouses to attend.

Councilor Schorer wanted to respond to Terry Callahan's comment regarding the five minute rule. I think we should have a monthly town hall meeting.

The Mayor stated that there is not a five minute rule, I have let citizens speak well over five minutes it is my decision.

Councilor Fortune says he truly appreciates the citizens who come in an address the council. I would like them to address the council with fact not rumor. The council approved the concerts in the Park and we do have a noise ordinance. He would also like to thank Frank Forbes for his participations with the negotiation for the Fire Dept.

Councilor Dreiling read a letter to respond to the Citizens Reform Committee. An electronic copy will be sent to the Recorder.

Council Kordosky stated that she could also hear the noise but she loves it. We could explore the possibility of a sound barrier.

Councilor Clark would like to expand on Glen Fortune's comments. She expanded on the comments from the Citizen Reform Committee. I think sometimes we could defer the comment to the right section for re-addressing.

Mayor Hampton stated that it might be a good idea to move the Councilor comments to behind the Public comments.
