### 2.0 PUBLIC COMMENT

**Eugene Cathcart, 76589 View Court, Oakridge, Healthy Dialogue.** I am glad to see healthy dialogue between the public and city council. I would like to see the council respond to public comment right after it is made rather than later in the meeting.

**Mayor Hampton** responded that a change in the agenda has been made and council will be responding right after public comments are made.

**Henri DeJonge, Trailer Business.** Our business had ten employees building trailers. The problem was drug and alcohol abuse. All ten employees were laid off because of drug and alcohol problems. She addressed the use of the Ditch Witch machine by City

Councilor Randy Dreiling. She said Randy is making money off of the Ditch Witch. His business benefits from this use.

Councilor Leary wanted to say what a beautiful and wonderful city Oakridge is. She knows Gordon Zimmerman is doing his job. She believes that character assassinations should not be a part of politics here.
