1.0 CALL MEETING TO ORDER

2.0 PUBLIC COMMENT

Kirk Troute, 76489 Walnut St. Oakridge: I just wanted to touch base with the council regarding the Just Us Festival in the park. This year all the money we raise will be going to Debbie Stalcup for her medical bills. I would like to see the Council consider letting people camp at the park. I realize we would have to have some rules. I don't think it should be about the money.

Mayor Hampton: We are not going to make a decision tonight. I would like to see you work with the staff on this issue. He wants the staff to make the recommendation to the Council.

Barbara Leary, 47675 West 1st St., was concerned talk about the speeding on West 2nd. If speed bumps are put on West 2nd coming around to Commercial, it would help.

Mayor Hampton: I am going to refer this to the Public Safety Committee. They can discuss possible solutions and bring them back to the Council.

Relay for Life solicited donations with the Mayor to match what was collected.

Councilor Dreiling: Mountain Bike Oregon pays a fee of about \$3,600 to rent the park. We don't just make donations.

Mayor Hampton: The Governor has signed a proclamation for the National Guard and wants all cities to do the same before they deploy again.

6.8 July 2, 2009 Council Meeting Discussion

Mayor Hampton requested discussion on whether to hold the July 2nd council meeting. Several members of the council stated they would be absent.

Councilor Fortune moved to cancel the July 2nd Council Meeting. Seconded by Councilor Clark. Mayor Hampton (Aye), A. Kordosky (Aye), R. Dreiling (Aye), R. Moe (Aye), R. Clark (Aye), G. Shorey (Aye), G. Fortune (Aye). Motion carried 7-0.

6.9 Railroad Quiet Zone Update

A discussion was held regarding the quiet zone and four options presented. The direction was to let the community vote on whether they want the quiet zones and what type of security measures should be taken. Gordon stated that we have some estimates on the cost of the quiet zone.

Councilor Dreiling stated that because there are no grant funds, the cost would need to be passed on to the citizens.

The consensus of the Council is to get more community input. There was discussion on how we want to do this. Do we want to do an election or survey? They discussed the costs of putting this on the ballot. The issue of when the vote should be held was raised. Because it would not cost the City if we waited for a general election, the Council felt we should wait.

Councilor Shorey asked if a night-time road closure was something that Klamath Falls pursued. He asked if this is an automated gate or a manual gate.

Gordon stated that it is a manual-shut gate. Someone would close the gate at 10:00 p.m. and open the gate up in the morning.

Councilor Clark says she has some issues with the fact that we have three accesses in this town to get from one side of town to the other. She doesn't want to turn off any of them. Looking at this from an emergency services standpoint, closing Beech Street doesn't make sense.

6.10 Just Us Music Festival Alcohol Permit

Councilor Clark moved to approve the facilities permit for the Oakridge Just Us Festival on August 1st and 2nd and waive the fee. Seconded by Councilor Shorey.

Councilor Kordosky asked about security.

Mr. Troute said they will have security. The beer garden will be fenced off.

Shorey (Aye), Mayor Hampton (Aye), A. Kordosky (Aye), R. Dreiling (Aye), G. Fortune (Aye), R. Clark (Aye). Motion carried 7-0.

8.3 Res. 13-2009 Recognizing Unanticipated Revenues for Peer Court

Councilor Fortune moved to approve Res. 13-2009 recognizing unanticipated revenue for the Oakridge Peer Court of \$2,625. Seconded by Councilor Moe. A. Kordosky (Aye), R. Dreiling (Aye), G. Fortune (Aye), R. Moe (Aye), Mayor Hampton (Aye), G. Shorey (Aye), R. Clark (Aye). Motion carried 7-0.

9.0 EMERGENCY SERVICES

We had a very successful open house last Saturday. Chief Demers wanted to thank the community for coming in. We sold hot dogs and kids played games.

10.0 REPORTS FROM BOARDS AND COMMITTEES

Councilor Kordosky reported that the Administration Committee will meet next Monday at 10:30.

Public Safety: Councilor Fortune said we have something to consider at the next meeting: speed bumps

LCOG: Mayor Hampton reported that the next meeting will be in Veneta in two weeks. In September we are going to have a planning meeting.

Chamber of Commerce: Councilor Clark indicated that the Annual Banquet is Saturday at 6:00 at the Willamette Activity Center.

Watershed Council: Mayor Hampton stated that it met last night. The topic was health insurance. They are going from one to three employees. It will take more than one meeting to figure out which plan will best serve the Watershed Council.

LRAPA: Councilor Fortune indicated that it passed the budget 5-4. It was a highly divided board meeting and very non-productive.

Treeplanting Festival: Councilor Kordosky stated that we had a final wrap up meeting. The parade went well. The street fair did not go so well. Mayor Hampton explained that there were a lot of suggestions regarding improvements to the festival.

Regional Fiber Consortium: Mayor Hampton commented that they will be meeting on June 29, 2009, to approve the budget for the upcoming year. They will also talk about strategies on how to make some money.

Parks, Trails and Trees: Councilor Dreiling said that we are looking for another committee member. It looks like we will get our \$25,000 grant for a Parks Master Plan. We were ranked #1 overall. One of the scorers ranked our project with 100 points out of 100 possible.

11.0 EXECUTIVE SESSION: ORS 192.660(2)(e) Property Negotiations

No action was taken coming out of the Executive Session.
