1.0 CALL MEETING TO ORDER / PLEDGE OF ALLEGIANCE

2.0 PUBLIC COMMENT

<u>Jess Henryes, 47737 Portal Drive, Oakridge-</u> Asked about Charter broadcasting the council meetings so everyone could watch and know what is going on.

3.0 MAYOR AND COUNCIL COMMENTS

Acting City Administrator Louis Gomez responded to Skip Baker, he said there is an issue with parking and they are resolving this.

The DOT does not claim the part of the rest area in question for camping during mountain biking events; it may be the City's property.

The parking at the OIP was an agreement between the former City Administrator and Randy.

Mayor Shorey has researched the ditch witch, some the records they can't find. We got this through a grant, as far as ownership, there are some gaps.

Cash on hand is low; we will keep an eye on that. May have to get a tax anticipation loan.

The railroad crossing at Beech Street will be closed from 7:30 a.m. on 8/20/12 until 8/23/12.

6.0 ADMINISTRATIVE SERVICES

6.1 Selection of new City Administrator

6.2 WAC Discussion

Chuck talked to the City Engineer, because DMV was in the building we were not eligible for low income grants. We really need to think about if we want to shut it down or try for grants. The WAC is a money eating machine.

6.3 Realtor of Record

Discussed having a realtor of record, we would be looking at 2-3%, not the customary 6%. We need someone to market the property for us.

We will have Realtors submit proposals to the City. All agreed to move forward with this.

6.4 LCOG Lease of space/easement on lot 39 OIP

The council discussed a utility easement on lot 39. LCOG wants to lease 400ft North of Kokanee Rd.

Larry Phipps suggested letting OEDAC make the decision, not the Council.

All agreed.

7.0 COMMUNITY SERVICES

7.1 Intergovernmental Agreement with Head Start of Lane County

We don't have the ability to clean the windows and carpets etc....We can leave the rent the same and take away the services.

Motion: Councilor Clark moved that the Mayor sign the Intergovernmental Agreement with Head Start of Lane County. Councilor Barclay seconded the motion.

We are hoping for a Christmas delivery for the ambulance.
