The vacant lot on Hwy 58, Ron Tyree will be up the week of the 16<sup>th</sup>, we will meet up at the OIP, will see if we can do a property swap.

The trail along Commercial Street, Louis talked to Dave D'Avanzo; he is trying to get him a map of how wide their easement is. Union Pacific is concerned about liability.

Regarding the website, Councilor Slaven and staff were on it today, the nice thing about it is people will be able to do a number of things on line, applications, building permits etc...

# 6.3 Chamber request for TRT Funds for visitors Guide

Randy Dreiling handed out a Visitors Guide to the Council.

Mr. Dreiling gave his presentation to the Council. There were some items that were not in the packet, he apologized for that.

They are printing 50,000 guides this time instead of 40,000; they will have approximately two new ads in the guide.

Mr. Dreiling asked for questions.

Councilor Coey asked if we have the money.

Louis said it would put us kind of short on being able to do some other things. He would recommend just doing \$1,000.

There was discussion whether this could be taken out of RTMP funds.

Louis said the RTMP is where we usually ask for applications at a certain time.

Mr. Dreiling said next year we should see a bump in the funds that we receive, next year is the Junior World Championships, we always get a bump when something like that is going on.

**Motion:** Councilor Fortune moved that we allocate \$1500.00 for the Oakridge/Westfir Visitors Guide. Councilor Clark seconded the motion.

Mayor Shorey asked what the proposed changes are to the visitors guide.

Mr. Dreiling said they are adding a rafting/paddling page and a family/kids page. Also, a little more information on Oakridge/Westfir like temperature guides.

There was discussion on where the visitor's guides will be put out.

They are put out at the Portland Airport, REI Stores, and Bike Shops etc..

Louis said with full time staff we offer a City rig, they can take that, if they choose to take their own vehicle then they don't get reimbursed for mileage.

Louis said this is something Councilor Coey wanted to talk about the cost difference with profit and non profit, should it be the same.

Councilor Coey said they could put this off for now.

# 6.5 Color Pallet

Louis showed the Council the new color pallet that the Planning Commission recommended.

This is strictly C-2 and C-3 districts.

# 7.1 Change Order No. 2 from C curb to curb and gutter

Louis went over the change order with the Council. The additional change order was for \$1,800 to add sidewalk to 15-20 ft gaps that would have just been dirt.

# 8.1 USDA Grant Proposal for new patrol cars

Chief Scobert requested the ability to enter in to a grant with USDA for new Police vehicles; there is a lot of money out there for this. This would give us the opportunity to obtain two brand new vehicles.

We have the ability to borrow from the water & Street funds to pick up our portion of the grant.

Mayor Shorey asked if we have an equipment reserve fund.

Louis said no we don't, we will have to establish a new line item.

There was discussion on whether we can borrow from these funds at this time. We are going to pay this off in four years.

Councilor Clark said there are safety issues to think about; one of the cars lights will go out unexpectedly.

Mayor Shorey said they have never had new police cars since he has been here.

Sandy Edds said our Police Department is working in a shabby office and they shouldn't have to drive unsafe cars.

**Motion:** Councilor Coey moved that we approve the USDA Grant Application for two (2) patrol cars and authorize an inter fund loan from water and sewer in the amount \$36,000 for the grant match portion. Councilor Clark seconded the motion.
