### 6.1 Second reading of Ordinance 907 Amending Text of Ordinance 874 Zoning and Land Use

Louis reported that Ordinance 907 was read at our last meeting and an amendment was made at that time. Councilors Kinyon and Buchmeier requested that language that would have prohibited the location of a marijuana facility within 1,000 ft of a daycare facility be removed. A motion to amend was made and passed, Mayor Coey and Councilor Rowland objecting. Language in the Ordinance has been updated to reflect the amendment

This Council is able to read an Ordinance by title only if they received the Ordinance seven or more days prior to their meeting and that we, at City Hall had it out and we did. Pages 12 and 14 that is where the primary amendments were made. We took out all of 500 ft language, we took out any other types of schools or daycares. We are left with career school, elementary school or secondary school.
