g) Commission Discussion

Commissioner Freborg said it states specifically that it must be a family member, that comes from State Code. That is what the Variance is for.

Louis said this is their code, not state code.

Commissioner Freborg asked if this is a professional caregiver.

Mr. Barber said she has worked as a caregiver and a CNA.

Commissioner Custer asked if they already have the motor home there or is this something that will need to move in.

LID – Recommendations from the U of O Community Planning/DEQ

Section 6.02 Uses and Structure

Commissioner Freborg said this is for a neighborhood commercial district, the way she understands it is if a property is zoned that, they can use it simply for a rain garden. Is that correct?

Commissioner Custer said yes, these are suggested measures.

Louis asked if they are talking green material roofs?

Commissioner Custer said no, they are talking growing a lawn up on your roof.

Louis said he likes 90% of this, we are doing most of it already, except the green roof piece having it so close to commercial.

Commissioner Freborg said it says including but not limited to, so if we exclude the green roofs then it can be including but not limited to everything except that. Then they can say we meant green roofs too.

Commissioner Custer said if we don't like green roofs then we can certainly exclude them. Anyone who wants to put on a green roof better have deep pockets, it is not an easy thing to do but, you are seeing them more and more all over the country.

Motion: Commissioner Alternus moved to accept section 6.02 Uses and Structures sub paragraph one permitted uses and structures to add paragraph (m). Commissioner Affa seconded the motion.

Commissioner Alternus asked to bring back 6.02 for discussion.

Commissioner Altemus said from his understanding is that stormwater mitigation measures are just defining encouragements to manage stormwater runoffs, it's not limited to, not saying what you can and can't do.

Commissioner Freborg said amended compost could be a problem.

There was discussion on what a green roof really is. Another term is living roof.

Commissioner Freborg said in the larger scheme of things, we are improving our tax base by making sure what goes in there is highest and best use, thereby ensuring a higher tax base and more livability and access to appropriate land use for those businesses that wish to grow in that area. You cannot put a business just anywhere so we have a limited inventory of property that meets this requirement and by allowing raw land, we are reducing that inventory and the tax base, we are also crowding out some businesses that may be viable in that particular zone.

Motion: Commissioner Altemus moved to reconsider 6.02 Uses and Structures. Commissioner Affa seconded the motion.

Motion: Commissioner Freborg moved to amend the previous motion that section 6.02 (1) paragraph (m) be amended to structures may contain stormwater mitigation measures including but not limited to, rain barrels and green or living roofs. Seconded by Commissioner Affa.

Commissioner Custer said we will table 6.02 and come back at another time.

Commissioner Affa moved to table section 6.02. Commissioner Freborg seconded the motion.

Section 6.06 Fences Walls and other Structures

Motion: Commissioner Affa moved to accept section 6.06 Fences Walls and other Structures. Commissioner Kordosky seconded the motion.

Louis said we have had complaints about neighbors with hedges over six feet or three feet; this is normally not an issue.

This is for an area like behind Les Schwab's, if there isn't an alley there would have to be a fence; where commercial meets residential.

This amendment is just saying they can use a hedge instead of a fence.

Section 6.09 Landscaping

Commissioner Custer said to remember the key word here is "preferably".

Motion: Commissioner Affa moved to accept section 6.09 Landscaping. Commissioner Alternus seconded the motion.

Louis wanted to look at the landscape standards.

Commissioner Custer said you can't say zero dirt is your landscaping scheme because it is going to become a problem.

Louis said exactly, they have to plant something.

Section 7.02 Uses and Structures

Motion: Commissioner Affa moved to accept 7.02 Uses and Structures. Commissioner Altemus seconded the motion.

Commissioner Freborg said it also says that any use allowed must not be objectionable

Section 7.08 Landscaping and Lighting

Motion: Commissioner Freborg moved to accept Section 7.08 Landscaping and Lighting to exclude green roofs. Commissioner Affa seconded the motion.

Commissioner Altemus asked if the previous items in black have already gone through the Planning Commission.

Louis said yes it has. The reason we are going through this again is because the DLCD has certain benchmarks they want to meet statewide and one of them is we have to take this process through Planning Commission, then City Council and then bring it back to them and let them know what changes we want to make. They still have to bless it even after the Council does it.
