## CHAPTER 70: GENERAL PROVISIONS

### § 70.01 TITLE.

This code may be cited as the “Uniform Traffic Code.”

### § 70.02 APPLICABILITY OF STATE LAW.

(A) (1) Except as provided herein, O.R.S. Chapter 153 and the State Vehicle Code, O.R.S. Chapter 801 to 822, are adopted by reference.

(2) Violation of an adopted provision of those chapters is an offense against this city.

(B) Violation of this provision as adopted herein is an offense against this city.

### § 70.03 DEFINITIONS.

For the purpose of this code, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

**BUS STOP.** A space on the edge of a roadway designated by sign for use by buses loading or unloading passengers.

**LOADING ZONE.** A space on the edge of a roadway designated by sign for the purpose of loading or unloading passengers or materials during specified hours of specified days.

**PERSON.** A natural person, firm, partnership, association or corporation.

**STREET.** The terms **HIGHWAY**, **ROAD** and **STREET** are as defined in O.R.S. 801.305.

**TRAFFIC LANE.** The area of the roadway used for the movement of a single line of traffic.

### § 70.04 ADMINISTRATION; AUTHORITY.

(A) (1) Subject to state laws, the City Council shall exercise all municipal traffic authority for the city, except those powers specifically and expressly delegated by this code or another ordinance.

(2) The powers of the Council include, but are not limited to:

- (a) Designation of through streets;
- (b) Designation of one-way streets;
- (c) Designation of truck routes;
- (d) Initiation of proceedings to change speed zones;
- (e) Revision of speed limits in parks;
- (f) Temporary blocking or closing of streets, except for emergency or construction activity under city staff direction;
- (g) Establishment of bicycle lanes and paths and traffic controls for the facilities;
- (h) Restriction of the use of certain streets by any class or kind of vehicle to protect the streets from damage;
- (i) Establishment of size and weight limitations governing the use of city streets; and
- (j) Establishment, removal or alteration of the following classes of traffic controls:

1. Crosswalks, safety zones and traffic lanes;

2. Intersection channelization and areas where drivers of vehicles shall not make right, left or U-turns and the time when the prohibition applies;

3. Parking areas and time limitations, including the form of permissible parking (such as parallel or diagonal);

4. Loading zones and stops for vehicles; and

5. Traffic control signals.

(B) (1) It is the duty of police officers to enforce the provisions of this code.

(2) In the event of a fire or other public emergency, officers of the police and fire departments may direct traffic as conditions require, notwithstanding the provisions of this code.

**§ 70.05 IMPLEMENTATION.**

The City Administrator or his or her designee shall implement the ordinances, resolutions and motions of the Council by installing, maintaining, removing and altering traffic-control devices. The installation shall be based on the standards contained in the *Oregon Manual on Uniform Traffic Control Devices for Streets and Highways*.

**§ 70.06 PUBLIC DANGER.**

Under conditions constituting a danger to the public, the Administrator or his or her designee may install temporary traffic-control devices.

**§ 70.07 TRAFFIC DESIGNS AND STANDARDS.**

The traffic designs and control device regulations of the Administrator or his or her designee shall be based on:

(A) Traffic engineering principles and traffic investigations;

(B) Standards, limitations and rules promulgated by the State Transportation Commission; and

(C) Other recognized traffic-control standards.

**§ 70.08 OBEDIENCE TO CONTROL DEVICES.**

(A) No person shall disobey the instruction of a police officer or traffic-control device.

(B) No unauthorized person shall install, move, remove, obstruct, alter the position of, deface or tamper with a traffic-control device or a marking, sign or device that regulates parking, stopping or standing.

**§ 70.09 EXISTING DEVICES AND MARKINGS.**

Parking and traffic-control devices and markings installed prior to the adoption of this code are lawfully authorized.

**§ 70.99 PENALTY.**

(A) Any person violating any provision of this code for which no penalty is prescribed shall be subject to § 10.99.

(B) Violation of a provision identical to a state statute is punishable by fine not to exceed the penalty prescribed by the state statute.

#### § 71.01 CROSSING PRIVATE PROPERTY.

No operator of a motor vehicle shall proceed from one street to another street by crossing private property or premises open to the public. This provision does not apply to the operator of a motor vehicle who stops on the property to procure or provide goods or services.

#### § 71.02 UNLAWFUL RIDING.

(A) No operator of a motor vehicle shall permit a passenger to, and no passenger shall, ride on a motor vehicle on a street, except on a portion of the vehicle designed or intended for the use of passengers. This provision does not apply to an employee engaged in the necessary discharge of a duty or to a person riding within a truck body in space intended for merchandise.

(B) No person shall board or alight from a motor vehicle while the vehicle is in motion on a street.

#### § 71.03 ROLLER SKATES, SLEDS AND THE LIKE.

(A) No person upon roller skates, a skateboard or riding in or by means of a coaster, toy vehicle or similar device shall use the streets, except while crossing at a crosswalk or in an authorized area.

(B) No person shall use the streets for traveling on skis, toboggans, sleds or similar devices, except where authorized.

#### § 71.04 DAMAGING SIDEWALKS AND CURBS.

(A) The operator of a motor vehicle shall not drive on a sidewalk or roadside planting strip, except to cross at a permanent or temporary driveway.

(B) No unauthorized person shall place dirt, wood or other material in the gutter or space next to the curb of a street with the intention of using it as a driveway.

(C) (1) No person shall remove a portion of a curb or move a motor vehicle or a device moved by a motor vehicle onto a curb or sidewalk without first obtaining authorization from the city and posting bond if required.

(2) A person who causes damage shall be responsible for the cost of repair.

#### **§ 71.05 REMOVING GLASS AND DEBRIS.**

A party to a vehicle accident or a person causing broken glass or other debris to be on a street shall remove the glass or other debris from the street.

#### **§ 71.06 STORAGE OF VEHICLES ON STREETS.**

No person shall store or permit to be stored on a street, without permission of the Council, a motor vehicle or personal property for a period in excess of seven consecutive days. Failure to remove a motor vehicle or other personal property after a period of seven consecutive days constitutes prima facie evidence of storage.

#### **§ 71.07 SPEED LIMITS IN PUBLIC PARKS.**

No person shall drive a vehicle on a street in a public park of this city at a speed exceeding 15 miles per hour unless signs erected indicate otherwise.

#### **§ 71.08 UNNECESSARY NOISE.**

No person shall operate a motor vehicle in the city in a manner as to create or cause excessive noise. The operation of compression brakes within the city is prohibited.

### **§ 72.01 PARKING ON PUBLIC PROPERTY.**

No person shall park a vehicle in excess of 48 hours on public property where parking is permitted unless authorized by the Council.

### **§ 72.02 OBSTRUCTING STREETS.**

No person shall park or leave on a street, parking strip, sidewalk or curb, a vehicle part, trailer, box, ware, merchandise of any description or any other thing that impedes traffic or obstructs the view, except

as is allowed by this chapter or other ordinances of the city.

### **§ 72.03 METHOD OF PARKING.**

(A) No person shall stand or park a motor vehicle in a street other than parallel with the edge of the roadway, headed in the direction of lawful traffic movement, and with the curbside wheels of the vehicle within 12 inches of the edge of the curb, except where the street is marked or signed for angle parking.

(B) Where parking spaces are designated on a street, no person shall stand or park a vehicle other than in the indicated direction and, within a single marked space unless the size or shape of the vehicle makes compliance impossible.

(C) When the operator of a vehicle discovers that the vehicle is parked close to a building to which the Fire Department has been summoned, the operator shall immediately remove the vehicle from the area unless otherwise directed by police or fire officers.

**§ 72.04 PROHIBITED PARKING OR STANDING.**

(A) No person shall park or stand:

(1) A vehicle in violation of state motor vehicle laws or in violation of a lawfully erected parking limitation sign or marking; and/or

(2) A vehicle in an alley other than for the expeditious loading or unloading of persons or materials, and in no case for a period in excess of 20 consecutive minutes in any two-hour period.

(B) No operator shall park and no owner shall allow a vehicle to be parked on a street for the principal purpose of:

(1) Displaying the vehicle for sale;

(2) Repairing or servicing the vehicle, except repairs necessitated by an emergency;

(3) Displaying advertising from the vehicle; and/or

(4) Selling merchandise from the vehicle, except when authorized.

**§ 72.05 USE OF LOADING ZONE; PASSENGERS.**

(A) (1) No person shall stop, stand or park a vehicle for any purpose or length of time other than for the expeditious loading or unloading of persons or materials, in a place designated as a loading zone when the hours applicable to that loading zone are in effect.

(2) When the hours applicable to the loading zone are in effect, the loading and unloading shall not exceed the time limits posted.

(3) If no time limits are posted, then the use of the zone shall not exceed five minutes for loading or unloading of passengers and personal baggage and 15 minutes for loading or unloading materials.

(B) No person shall stop, stand or park a vehicle for any purpose or length of time other than for the expeditious loading or unloading of passengers in a place designated as a passenger loading zone when the hours applicable to that zone are in effect.

**§ 72.06 LIGHTS ON PARKED VEHICLE.**

No lights need be displayed upon a vehicle that is parked in accordance with this chapter on a street where there is sufficient light to reveal a person or object at a distance of at least 300 feet from the vehicle.

**§ 72.07 EXTENSION OF TIME.**

Where maximum parking time limits are designated by sign, movement of a vehicle within a block shall not extend the time limits for parking.

**§ 72.08 UNATTENDED VEHICLES.**

When a police officer finds a motor vehicle parked or standing unattended with the ignition key in the vehicle, the officer is authorized to remove the key from the vehicle and deliver the key to the person in charge of the police station.

**§ 72.09 EXEMPTIONS.**

The provisions of this chapter that regulate the parking, stopping or standing of vehicles do not apply to:

(A) A vehicle of the city, county, state or a public utility while necessarily in use for construction or repair work on a street;

(B) A vehicle owned by the United States while in use for the collection, transportation or delivery of mail; and/or

(C) A vehicle of a disabled person who complies with the provisions of O.R.S. 811.615 to 811.632.

**§ 72.10 PARKING CITATION;  
RESPONSIBILITY.**

(A) When a vehicle without an operator is found parked in violation of a restriction imposed by this chapter, the officer finding the vehicle shall take its license number and any other information displayed on the vehicle that may identify its owner, and shall conspicuously affix to the vehicle a parking citation

instructing the operator to answer to the charge or pay the penalty imposed within five days during specific hours and at a specific place.

(B) If the operator does not respond to a parking citation affixed to a vehicle within five working days, the Municipal Court may send a letter to the owner of the vehicle informing the owner of the violation and giving notice that if the citation is disregarded for a period of ten days:

(1) The fine will be doubled; and

(2) The vehicle is subject to impoundment and may be sold if not redeemed.

(C) The owner of a vehicle in violation of a parking restriction shall be responsible for the offense unless the use of the vehicle was secured by the operator without the owner's consent.

(D) In a proceeding against a vehicle owner charging a violation of a restriction on parking, proof that the vehicle was registered to the defendant at the time of the violation shall constitute a presumption that the defendant was the owner.

## CHAPTER 73: BICYCLES

(D) If the owner of a bicycle impounded under this chapter can be readily determined, the police shall make reasonable efforts to notify the owner.

### § 73.01 OPERATING RULES.

In addition to observing all other applicable provisions of this code and state law pertaining to bicycles, no person shall leave a bicycle, except in a bicycle rack. If no rack is provided, the person shall leave the bicycle so as not to obstruct any roadway, sidewalk, driveway or building entrance. (Ord. 711, passed 3-20-86; Am. Ord. 800, passed 12-15-94; Am. (E) A bicycle impounded under this chapter that remains unclaimed shall be disposed of in accordance with the city's procedures for disposal of abandoned or lost personal property. (Ord. 711, passed 3-20-86; Am. Ord. 800, passed 12-15-94; Am. Ord. 808, passed 9-21-95; Am. Ord. 835, passed 6-17-99) Penalty, see § 70.99

### § 73.02 IMPOUNDMENT.

(A) No person shall leave a bicycle on private property without the consent of the owner or person in charge. Consent is implied on private business property unless bicycle parking is expressly prohibited.

(B) A bicycle left on public property for a period in excess of 24 hours may be impounded by the Police Department.

(C) In addition to any citation issued, a bicycle parked in violation of this chapter, that obstructs or impedes the free flow of pedestrian or vehicular traffic or otherwise endangers the public, may be immediately impounded by the Police Department.





## CHAPTER 74: PEDESTRIANS

#### § 74.01 CROSSING OUTSIDE CROSSWALKS.

No pedestrian, when crossing a street other than within a crosswalk, shall cross in a manner that impedes traffic.

#### § 74.02 CROSSING AT RIGHT ANGLES.

No pedestrian shall cross a street other than by a route at right angles to the curb or by the shortest route to the opposite curb, unless crossing within a crosswalk.

#### § 74.03 PEDESTRIAN MALL.

(A) *Mall established.* The City Council hereby declares and determines that the proposed pedestrian mall on Elder Street, extending the length of School District No. 76's property between 1st and 2nd Streets, and as more particularly described in the Council's Resolution of Intent, Resolution No. 03-2003, is finally established.

(B) *Hours of closure.* Vehicular traffic shall be prohibited on the above-described pedestrian mall only during school hours, while school is in session. Elder Street will be open to vehicular traffic during school holidays, vacations, and outside of school hours every day school is in session. A Memorandum of Understanding to be entered into between the City of Oakridge and School District No. 76 will establish more detailed rules and regulations pertaining to the use, operation, and maintenance of the Elder Street Pedestrian Mall.

(C) *Mall operative date.* The above referenced Memorandum of Understanding and associated rules and regulations shall be operative as of the first day of the 2003-2004 school year, and continue in force thereafter until amended or appealed by the City Council.

## CHAPTER 75: PARADES AND PROCESSIONS

(3) The desired route, including assembling points;

(4) The number of persons, vehicles and animals that will be participating in the parade; and

(5) The proposed starting and ending time.

### § 75.01 PROHIBITED ACTIVITY.

No person shall organize or participate in a parade on a public street without obtaining a permit. A permit shall always be required of a procession of people using the public right-of-way and consisting of 100 or more persons or ten or more vehicles. (Ord. 711, passed 3-20-86; Am. Ord. 800, passed 12-15-94; Am. Ord. 808, passed 9-21-95; Am. Ord. 835, passed 6-17-99) Penalty, see § 70.99

(C) The application shall be signed by the person designated as the Chairperson.

(D) The Police Chief shall issue a parade permit conditioned on the applicant's written agreement to comply with the terms of the permit unless the Chief finds that:

(1) The time, route, and size of the parade will unreasonably disrupt the movement of other traffic;

### § 75.02 PERMIT REQUIRED.

(A) Application for parade permits shall be made to the Police Chief at least seven days prior to the intended date of the parade, unless the time is waived by the Chief.

(B) Applications shall include the following information:

(1) The name and address of the person responsible for the proposed parade;

(2) The date of the proposed parade;

(2) The parade is of a size or nature that requires the diversion of so great a number of police officers to properly police the line of movement and contiguous areas that allowing the parade would deny reasonable police protection to the city;

(3) The parade will interfere with another parade for which a permit has already been issued;

(4) Information contained in the application is found to be false or a material detail is omitted; and/or

(5) The applicant refuses to agree to abide by or comply with all conditions of the permit.

(E) If one or more of the conditions listed in division (D) above, other than division (D)(5) above, exists, the Police Chief may impose reasonable conditions in the permit, including but not limited to:

- (1) Requiring an alternate date;
- (2) Requiring an alternate route; and/or
- (3) Restricting the size of the parade.

(F) The Police Chief shall notify the applicant of the decision within three days after receipt of the application.

(G) If the Police Chief proposes alternatives or refuses to issue a permit, the applicant shall have the right to appeal the decision to the Council. (Ord. 711, passed 3-20-86; Am. Ord. 800, passed 12-15-94; Am. Ord. 808, passed 9-21-95; Am. Ord. 835, passed 6-17-99)

### **§ 75.03 APPEAL TO COUNCIL.**

(A) An applicant may appeal the decision of the Police Chief by filing a written request of appeal with the City Recorder within 48 hours after the Chief has proposed alternatives or refused to issue a permit.

(B) The Council shall schedule a hearing date, which shall not be later than three days following the filing of the written appeal with the City Recorder, and shall notify the applicant of the date and time that he or she may appear either in person or by a representative. ### **§ 75.04 OFFENSES AGAINST PARADES.**

No person shall unreasonably interfere with a parade or parade participant. No person shall operate

a vehicle that is not part of a parade between the vehicles or persons comprising a parade.

### **§ 75.05 REVOCATION OF PERMIT.**

The Police Chief may revoke a parade permit if circumstances clearly show that the parade can no longer be conducted consistent with public safety. (Ord. 711, passed 3-20-86; Am. Ord. 800, passed 12-15-94; Am. Ord. 808, passed 9-21-95; Am. Ord. 835, passed 6-17-99)

### **§ 75.06 FUNERAL PROCESSIONS.**

(A) No permit is required for a funeral procession.

(B) A funeral procession shall proceed to the place of interment by the most direct route that is both legal and practical.

(C) The procession shall be accompanied by adequate escort vehicles for traffic control.

(D) All motor vehicles in the funeral procession shall be operated with their lights on.

(E) No person shall unreasonably interfere with a funeral procession.

(F) No person shall operate a vehicle that is not a part of the procession between the vehicles of a funeral procession.
