ORDINANCE NO. 931

AN ORDINANCE AMENDING THE OAKRIDGE CITY POLICIES RELATING TO PROCEDURES FOR PUBLIC CONTRACTING BY ADOPTING EXCEPT AS HEREIN SPECIFIED, STATE OF OREGON PUBLIC CONTRACT REQUIREMENTS AS SET FORTH IN ORS 279, 279A, 279B AND 279C, "THE PUBLIC CONTRACTING CODE", AND THE MODEL RULES ADOPTED BY THE ATTORNEY GENERAL OF THE STATE OF OREGON AS SET FORTH IN APPLICABLE OREGON ADMINISTRATIVE RULES, DIVISION 46, GENERAL PROVISIONS RELATED TO PUBLIC CONTRACTING OAR 137-046-0100 ET SEQ., DIVISION 47, PUBLIC PROCUREMENTS FOR GOODS OR SERVICES, OAR 137-047-0100 ET SEQ., DIVISION 48, CONSULTANT SELECTION: ARCHITECTURAL, ENGINEERING, LAND SURVEYING AND RELATED SERVICES CONTRACTS, OAR 137-048-0100 ET SEQ., AND DIVISION 49, GENERAL PROVISIONS RELATED TO PUBLIC CONTRACTS FOR CONSTRUCTION SERVICES, OAR 137-049-0100 ET SEQ., REPEALING ORDINANCE NO. 837 AND DECLARING AN EMERGENCY

WHEREAS: The Oregon Legislature adopted HB 2341 (2003 Oregon Laws, Chapter 794) ("The Public Contracting Code"), which was signed by the Governor, and has an operative date of March 1, 2005, and

WHEREAS: The Public Contracting Code requires City of Oakridge to designate a Local Contract Review Board, and to adopt contracting rules in areas not covered by the Public Contracting Code or "Model Rules" adopted by the attorney general of the state of Oregon as set forth in applicable Oregon Administrative Rules Division 46, General Provisions Related to Public Contracting OAR 137-046-0100 et seq., and specifically OAR 137-046-0000(1), Division 47, Public Procurements for Goods or Services, OAR 137-047-0100 et seq., Division 48, Consultant Selection: Architectural, Engineering, Land Surveying and Related Services Contracts, OAR 137-048-0100 et seq., and Division 49, General Provisions Related to Public Contracts for Construction Services, OAR 137-049-0100 et seq, and

NOW THEREFORE, City of Oakridge ordains as follows:

Section 1. Oakridge City Ordinance No. 837, adopted April 6, 2000 is hereby repealed. This Ordinance supersedes Oakridge City Resolutions 08-2005 and 04-2011. All actions taken or existing contracts awarded under Ordinance No. 837, Resolutions 08-2005 and 04-2011 are hereby ratified and affirmed.

Section 2. The City Council for the City of Oakridge, Oregon is hereby designated as the Local Contract Review Board to act on such matters on behalf of Oakridge,

Section 3. The City Administrator is hereby instructed to file a copy of this Ordinance with the Board of County Commissioners of Lane County, Oregon.

Section 4. Except as specifically provided in this ordinance, public contracts and purchases shall be awarded, administered and governed according to the applicable requirements of ORS Chapters 279, 279A, 279B and 279C (the "Public Contracting Code") and the Attorney General's Model Public Contract Rules ("Model Rules") as set forth in applicable Oregon Administrative Rules Division 46, General Provisions Related to Public Contracting OAR 137-046-0100 et seq., and specifically OAR 137-046-0100(1), Division 47, Public Procurements for Goods or Services, OAR 137-047-0000 et seq., Division 48, Consultant Section: Architectural Engineering, Land Surveying and Related Services Contracts, OAR 137-048-0100 et seq. and Division 49, General Provisions Related to Public Contracts for Construction Services, OAR 137-049-0100 et seq., as they now exist.

Section 5. The "Oakridge Policy for Public Contracting & Purchasing" is attached hereto, incorporated herein, and adopted by and through this Ordinance.

Section 6. As the matter contained herein concerns the public's welfare and safety, an emergency is declared to exist, and this Ordinance shall take effect immediately upon its passage.
