He is asking for direction on the fence slats, he wants to follow code.

Fred Aldrich Pastor at the Assembly of God Church- This is not really a statement in opposition, just a clarification, in reading he said the hours will be regular 8-5, but what days of the week? Chainsaw noise carries considerably and he would hate to have that interrupt the morning worship service. The zoning or contract says nothing about cleaning up after a year, that will leave a lot of saw dust and a lot of bark, but he does think this is a great idea and it serves the community well.

Commissioner Taylor said so "no woodcutting activity" instead of chainsaw activity.

Rick said sure, he thinks that is much better, that is why he asked about the sales.
