### Amendments to Oakridge Zoning and/or Comprehensive Plan

The City of Oakridge Planning Commission will hold a Public Hearing at **7:00 p.m. on Tuesday March 17<sup>th</sup> 2020 at the Council Chambers located at the Willamette Activity Center Room 8, 47674 School Street, Oakridge OR, 97463** to consider proposing recommendations to City Council on adoption of the 2020 Oakridge Transportation System Plan.

### Summary of Proposed Adoption

The City of Oakridge Transportation System Plan (TSP) is a long-range plan that sets the vision for the city's transportation system, facilities, and services to meet state, regional, and local needs for the next 20 years. The purpose of the TSP update is to address growth in Oakridge as well as regulatory changes that have occurred since adoption of the City's previous TSP. Within the proposed TSP will be proposed amendments to the City of Oakridge Land Use, Development Codes and for the TSP to be adopted as the Transportation element of the Comprehensive Plan. The overall principles of the TSP are to assist in meeting the following goals:

Goal 1 – Economic Development

Goal 2 – Transportation System Characteristics

Goal 3 – Mobility for All

Goal 4 – Transportation and Land Use Planning

Goal 5 – Plan Implementation

Goal 6 – Safety
